



X. ANY OTHER OBSERVATIONS:

1. The previous Review Committee recommendations are substantially not complied, though the college has potential and ability to carry out all the recommendations of the previous Review Committee recommendations.
2. The various bodies to be constituted as per Sec 6 of Statute relating to the Autonomous Status of Colleges and Institutions, 2009 are constituted and periodical meetings are conducted.
3. The University admission approval of the students admitted to the college as prescribed under Sec.13 (iv) of the Statute is carried out.
4. Section 15 (a) of the Statute mandates that "Each autonomous college/institution shall constitute appropriate committees to evaluate its academic performance, improvement of standards and to assess how best it has used the autonomous status.
5. Each self-evaluation shall be done at the end of every academic year and the report of the self evaluation shall be submitted to the University every year by 31st of July. The same has not been submitted to the University.
6. Section 17 of statute mandates that "The college/institution which has been granted autonomous status shall submit to the University, at the end of each academic year and within one month from the expiry of the academic year, the following information in such format as may be prescribed by general or special order of the University." However, this periodical information has not been submitted to University.
7. The question papers for various LL. B Courses are only in English language.
8. Promotion of teachers, as per UGC Regulations has not been provided for the teachers under grant in aid.
9. LL.M Course requires teaching staff such as Professors and Associate Professors.
10. Few students have taken admission for LL M Course and students admission needs to be strengthened.
11. Admission to 5 years B.A/B.B.A., LL. B (Hons) Courses is done only by taking interview of the students and not on the basis of written admission test.
12. The Principles of Research which is an important subject for Honor's Courses is offered in the 10th semester instead of 1st semester. Some of the important subjects like Intellectual Property Rights are offered as optional subjects. As such syllabus needs to be revised and restructured.
13. The library needs to be strengthened with more prescribed books for LL. B and LL M Courses and also online resources such Hein online, west law, SCC online etc.
14. The college is having Principal on in charge basis.


XI. CONDITIONS OF THE REVIEW COMMITTEE

1. Self evaluation reports as per Section 17 of the Statute shall be submitted to university.
2. The periodical reports and statements under Section 17 of the Statute shall be submitted to university.
3. The college shall provide UGC Scale to the faculty members having UGC qualifications. For rest of the teaching staff State scale shall be provided.
4. As per the UGC Regulations, the promotion policy has to be implemented for the teachers in grant in aid.
5. The written entrance test for the admission to 5 years B.A./B.B.A., LL. B (Hons) shall be introduced.
6. In view of the bilingual policy under NEP, the teaching and examination shall be ensured accordingly and question papers for various LL. B courses shall be in Kannada and English.
7. The syllabus shall be restructured and revised to include Principles of Research in the 1st Semester for Honor's courses and important compulsory subjects shall not be offered as optional papers.
8. As per UGC Regulations, required teaching staff for LL.M Course such as Professors and Associate Professors to be appointed.
9. The principal of the college shall be on regular basis and not as in charge Principal.
10. The library shall be strengthened with adequate reference and standard books required for both the LL. M and LL. B students.
11. At least minimum 5 online resources shall be subscribed for the better resources of the library.
12. The research activities of the teachers such as publication and research projects shall be encouraged.






