Dr. S. Nataraju, Principal and Chairman of the Academic Council welcomed the members. The meeting was held through both online/offline and the chairman asked the Sri. Jagadish A.T, Member-Secretary made presentation before the august body.

The following resolutions were passed during the deliberations of the meeting:

Agenda 29.1: Reading and recording of the Proceedings of the 28th Academic Council Meeting.

The member-secretary briefed the proceedings of the previous 28th AC meeting and also about the action taken report to the members. The suggestions made in the previous 28th AC meeting held on 27th November 2021, were briefed to the members; where, Dr. Tharanath sought clarification regarding the seed money and the use of same for NAAC Criteria. Dr. N. Vanishree replied that leave, registration fees and OOD is given and Dr. Nataraju.S clarified that the seed money will partially to benefit the faculty members.

Decision: It was accepted and implemented.

Agenda 29.2 APPROVAL OF THE RECOMMENDATIONS OF THE BOS (UG)

During the deliberations of the 21st BOS (UG) meeting held on 4.6.2022 the following recommendations have been arrived by the members of the BOS (UG) which are placed before Academic Council.

- Property Law: It was resolved to carry out realignment of the topic – Sale from IV to be shifted to Unit III after the topic – part performance.
- SWAYAM Course Draft Regulations was accepted by the members and was resolved to be implemented from 2021-22.
- The existing Internship Rules and Regulations were accepted by the members and the same shall be continued.
- Review of Clinical Examinations - it was resolved to continue with the existing syllabus in the clinical papers. It was recommended 1) to update the reference books for Clinic III (ADR) and 2) Clinic IV – Litigation, Advocacy and Moot Court to provide more practical knowledge on Pre-Trial preparation to the students with the help of a lawyer in the college premises itself.
- The members were satisfied with the short term courses and value added courses offered in the college and the same was accepted.
- It was resolved to continue with the existing CIA components.
- It was resolved to include a course on Legal Research during the first year of the programme.
- The members recommended the college to enter MoUs with various law colleges.
- It was resolved to relook and realign the optional papers offered under all programmes.

Smt. Sheela Ganesh introduced the recommendations of BOS (UG). Sri. S.R.Somasekhara clarified that The Probation of Offenders Act, 1958 should be retained in Cr.P.C Syllabus and

POCSO and Juvenile Justice (Care and Protection of Children) Act, 2015 can be included in IPC Syllabus.

- **Decision: It was accepted.**

Agenda 29.3 RECOMMENDATIONS OF THE BOS (PG) TO THE ACADEMIC COUNCIL

The following are the recommendations of the Board of Studies (PG) meeting held on 4.6.2022 for the approval from the Academic Council:

- The revised list of courses offered along with the nomenclature for the PG programme to be approved. (Topic on Role of BCI and Digital Technology in the Course Legal Education and Research Methodology to be added).
- Publication of papers, articles and write ups in journals is a must for the PG students to get better grades.
- Proposal by the external member to start 1 year PG program on Investment Laws.
- Proposal to conduct the classes for PG program in the evening so that the advocates can join the course thereby increasing the admissions of PG students.
- The following distribution of marks was proposed by the esteemed members:

The above changes were approved by the members of the Board of Studies (Post Graduation) for implementation from 2022-23.

For the proposal to conduct the classes for PG program in the evening, so that the advocates can join the course and thereby increasing the admissions of PG students, Dr. Tharanth sought clarification can the practicing lawyers do LL.M. Prof. Nagendramurthy M.P replied that the latest regulations has allowed for change in the timings and college will look through the opportunities available. For the clarification sought on Viva-voce for 50 Marks, it was replied that, after the end of every semester there will Viva-Voce conducted and hence 50 Marks is allotted. Sri. Y G Muralidharan insisted on starting new PG Courses on IPR, Technology Law etc. and tailor the course according to the needs of students and industry oriented courses. Sri. S.R.Somasekhara opined Procedural Law PG Programme will not serve purpose.

- Train students on procedural aspects of Labour Courts, Industrial Tribunals, and practical aspects of investigation of crime (by a police officer), training in Arbitration and Conciliation proceedings.
- Students to read Janasamayarigagi Kannunu circulated by the Legal Services Authority.
