MOOT COURT ACTIVITIES:

MOOT ORIENTATION FOR FRESHERS

The orientation for the freshers was conducted in the silver jubilee hall of JSS Law College (Autonomous), Mysore, at 2.30pm on 22nd September, 2022, as a part of IQAC initiative of the institution. The words of the Hon'ble Justice were effectively inspiring to the member students of the society while also motivating to participate in all the events and competitions.

Further, Principal Sir distributed the badges and appointment certificates to the convenors and permanent secretariat of the society followed by which the prizes for competitions conducted during previous year by the society were distributed.

REPORT ON THE INTRA-COLLEGIATE MOOT COURT COMPETITION 2022-23

JSS Law College (Autonomous), Mysore conducted its Intra-Collegiate Moot Court Competition 2022-23 in its campus from 17th November 2022 to 19th November 2022. 44 teams participated over the course of 3 days. On the first day, 2 preliminary rounds were held for 44 teams from 10:30 am till 6:30 pm, according to the draw of lots held the previous day. The results of the round were announced by the Convenors at 7:00 pm, along with the draw of lots, where only top 16 teams qualified for the Octa-finals scheduled to be held the on the second day, Octa-finals were conducted in 8 court halls at 2:30pm. Judges were invited from outside the college who were practicing advocates and academicians. Top 8 teams were

declared as quarter-finalists. The quarter-final round was scheduled to be from 5:00 pm to 6:30 pm. The results for the same were declared at 7:00pm. Draw of lots were conducted at the same time for the semi-finals round to be held the following day at 10:30 am. The top 4 teams qualified for the same.

For the final day, the semi-final rounds commenced at 10:30 am with 45 minutes allotted per team to make their submissions. The finals were scheduled at 6:00 pm with Ms. Vela Damodar Khoday, (Principal Judge, Family Court, Mysore), Mr. Mallikarjun (V Addl. District and Sessions Judge, Mysore), and Mr. Devaraj Bhute (Member Secretary, DLSA, Mysore) as the judges as well as the guests of honour for the Valedictory which began at 8.00 pm and concluded at 9.30 pm.

Event Host and Panel Introduction:

Liya Ann Francis served as the host for the program, skillfully guiding the proceedings. Professor Asma, a distinguished faculty member, introduced the esteemed panelists who were all alumni from the 2019 batch of JSS Law College. The panelists for the event were Siddhant S Darira, Meemansa Singh, and Mannan Khan.

Panelist 1: Siddhant S Darira:

Siddhant S Darira, a prominent legal practitioner who initially worked at Holla and Holla Associates, shared his valuable insights with the audience. He emphasized the stark differences

between moot court competitions and actual court proceedings, highlighting the significance of frequent court appearances and the invaluable guidance of senior advocates. Siddhant concluded by underscoring the significance of personal growth and staying updated in the ever-evolving field of law.

Panelist 2: Meemansa Singh:

Meemansa Singh, a Mahatma Gandhi National Fellow under the Ministry of Skill Development and Entrepreneurship, Government of India, took the stage and expressed her delight at returning to the platform where she had once hosted events as a student. She shared her understanding of self-awareness and the significance of answering life questions in interviews, rather than solely focusing on legal knowledge. Meemansa emphasized the value of internships and the need to find mentors during these experiences, highlighting their role in shaping a successful legal career.

Panelist 3: Mannan Khan:

Mannan Khan, an advocate specializing in tax law, brought a light-hearted and humorous tone to his speech. He reflected on his journey as an average student and shared an anecdote about filing a Public Interest Litigation (PIL) on behalf of students to postpone the Comed-K exams. He encouraged aspiring lawyers to explore various practice areas within the legal profession.

In conclusion, the event "From the Classroom to the Courtroom: Exploring the Career Trajectories of Law Graduates" proved to be an educational and eye-opening experience for all attendees.

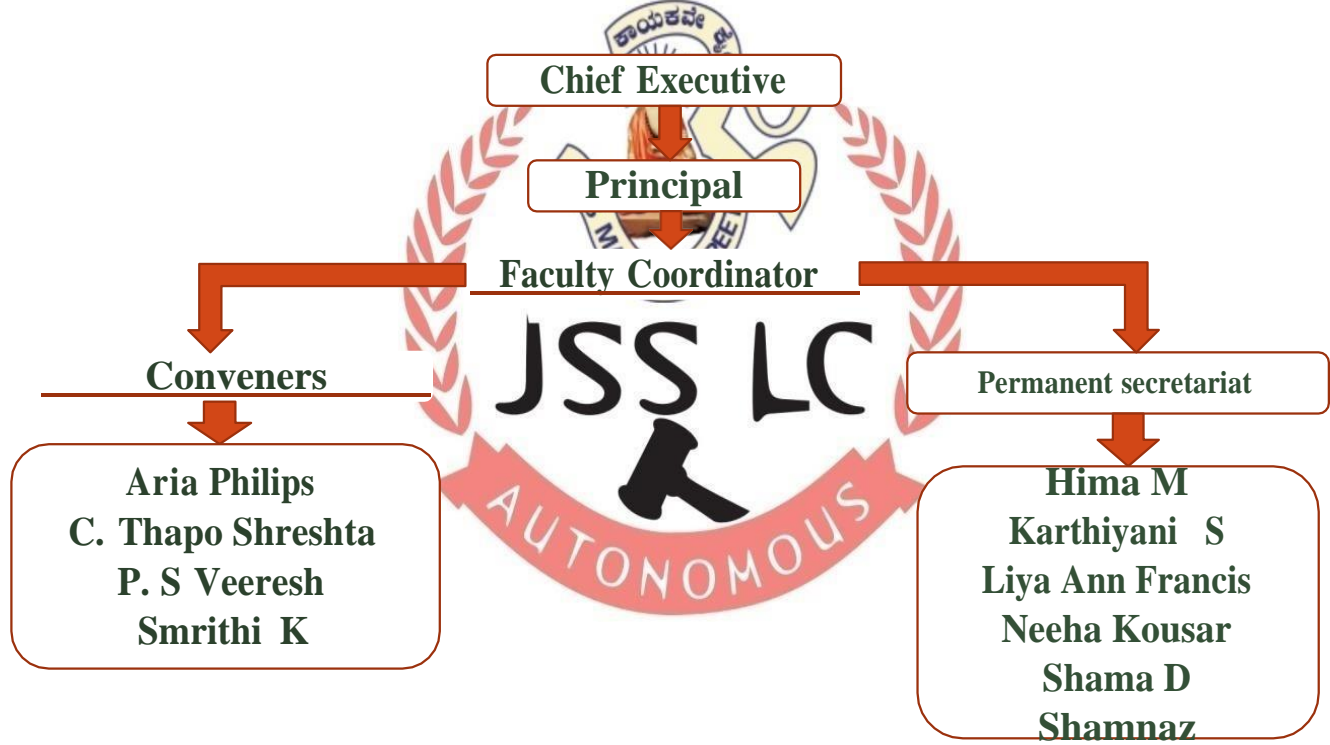

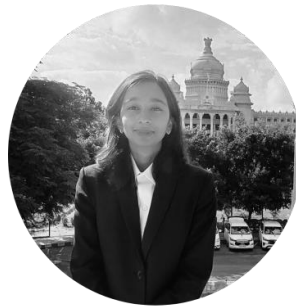

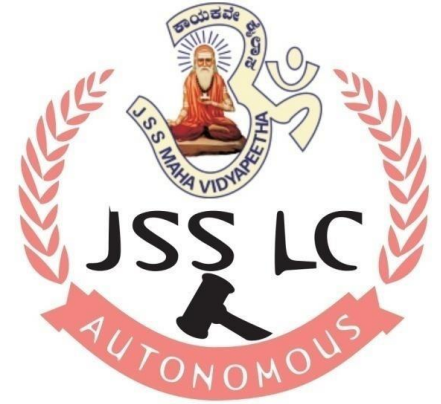
JSSLC MOOT COURT SOCIETY

Karnataka State Law University, Hubli has introduced Moot Court Training as a Practical subject for the final year students of the new Integrated Semester course.

Henceforth, a Moot Court Club has been constituted in the year 1999.

This club has a membership of all the interested students of the college.

At the beginning of the academic year they form a team of office bearers to facilitate the smooth conduction of Moot Court activities.



MOOT COURT : INTRODUCTION

- ❖ Moot Court is a mock court in which law students argue imaginary cases for practice.
- ❖ A moot court is like simulating a real court, where students are made to participate in the staged court proceedings that are related to a fictional dispute between parties.
- ❖ The training equips a law student to cope successfully with the strains of profession in the courts of law.
- ❖ It also imparts several essential skills such as Research, data analysis, framing of the issues and contentions, examining and cross-examining and presenting the arguments.
- ❖ It enables the student to learn the science of drafting of conveyances, pleadings and memorials.



BENEFITS OF MOOT COURT

- ❖ Moot Court competition will also increase the level of awareness and understanding of the mandate and activities of the Court. Furthermore, it will promote access and facilitate understanding of the judicial processes at the Court.
- ❖ Moot Court is a venue, where the analysis, drafting, presentation and arguing skills of an upcoming lawyer are put to test.
- ❖ Legal training anywhere in the world requires the capacity to objectively assess the facts, apply relevant principles of law and legislation and bring out reasons and arguments to justify ones stand.
- ❖ To assists the students of the college to develop their faculties of rational thinking, articulation, presentation of arguments and moreover strives to inculcate in each of the students, the spirit of professionalism, leadership and a strong desire for acquiring legal knowledge.

GENERAL PROTOCOL (JSSLC-MCS)

RULES 2022-23

- ❖ RULE 1: Every member of the Moot Court Club shall be bound to attend all the meetings and sessions. Provided, by reason of any genuine engagement, if any member fails to attend, he or she shall inform the same to the Faculty Coordinator.
- ❖ RULE 2 : Every member of the Moot Court Club is allowed to participate in one National Moot in the odd semester and thereafter shall participate in the Intra- Collegiate Moot Court Competition in order to participate in another National Moot Court Competition.
- ❖ RULE 3: Every team intending to participate in National Moot shall inform the student coordinators of the date , place, institution organizing the National Moot and details of the team. The same shall be mentioned in a letter to be submitted to the Faculty Coordinator. Before registering to the said National Moot Court Competition

GENERAL PROTOCOL (JSSLC-MCS)

RULES 2022-23

- ❖ RULE 4: Every Team that has registered for a National Moot shall be bound to submit their Memorials to the Student Coordinators or the core Committee Members 3 days before their final submissions.
- ❖ RULE 5: Every team that has submitted their memorials to the institution organizing the said National Moot, shall be bound to argue before the demo bench on such date as may be specified.
 - ❖ EXPLANTION: Demo Bench is a bench of judges that hears the arguments of the Team going for a National Moot as a measure of ensuring their readiness, evaluating their preparation and assisting in correcting their errors.

GENERAL PROTOCOL (JSSLC-MCS)

RULES 2022-23

- ❖ RULE 6: Every Team that has participated in a National Moot shall be bound to submit a report on the same along with a copy of the certificates and photographs (if any).
- ❖ RULE 7 : The attendance for the teams going for National Moots shall be as may be decided by the Faculty Coordinator.
- ❖ RULE 8: Any kind of delinquency of the above said rules will attract such action as the Faculty Coordinator may decide in the interest of equity.

TRAINING SESSIONS

- ❖ Training sessions on various aspects of law will be organized by JSSLC Moot Court Club and these sessions will be addressed by resourced personnel who has vast experiences in the legal field, renowned Law practitioners and Leading Advocates.
- ❖ Training sessions will be conducted for all the activities organized by the Moot Court Club, which includes a detailed training on how to aptly research and prepare memorials for the same

ARBITRATION

- ❖ **Arbitration Competitions promote greater knowledge in arbitration by simulating a realistic arbitration hearing. Participants prepare and present an arbitration case, including opening statements, exhibit introductions, evidentiary presentations, and summations.**
- ❖ **In arbitration, parties have ample choice: They can choose the law which applies to their dispute, who will decide their dispute, where their dispute will be decided, in what language their dispute will be decided, whether there will be oral pleadings or written submissions only, if there will be written witness statements, inter alia.**
- **The parties do not have to subject themselves to a legal system that may be unknown to them.**
- **They are at liberty to choose a neutral panel and a procedure that reflects both parties' origins and interests**

What is Mediation?

- Mediation is a process devised to settle disputes between parties.
 - It is a quick method to resolve disputes between two parties confidentially.
 - It is performed by a neutral party who is chosen by both the parties mutually.
 - Mediation is non-binding, unlike arbitration. Parties are free to leave.
 - Parties can get a better bargain and save a lot of time as well.
 - Issues are decided based on facts in Courts, but in mediation, parties reach an agreement beneficial to both.

By participating in such competition, students get a chance of inner growth, which whatever they pursue in their career will never go waste.

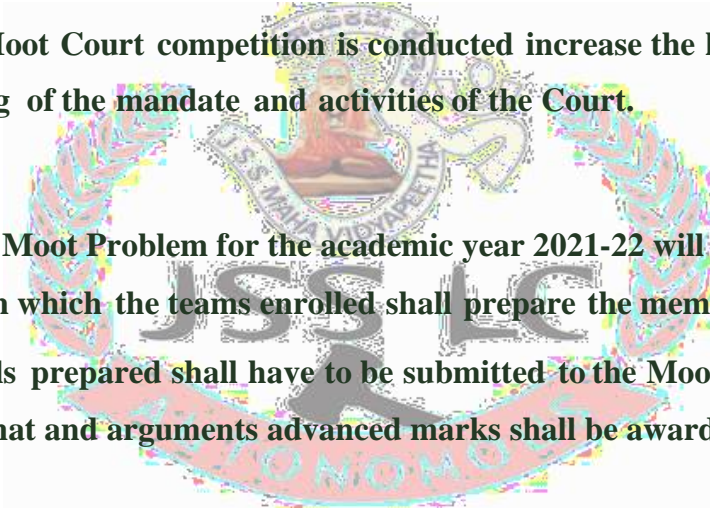
INTRA CLASS MOOT COURT COMPETITION 2022-23

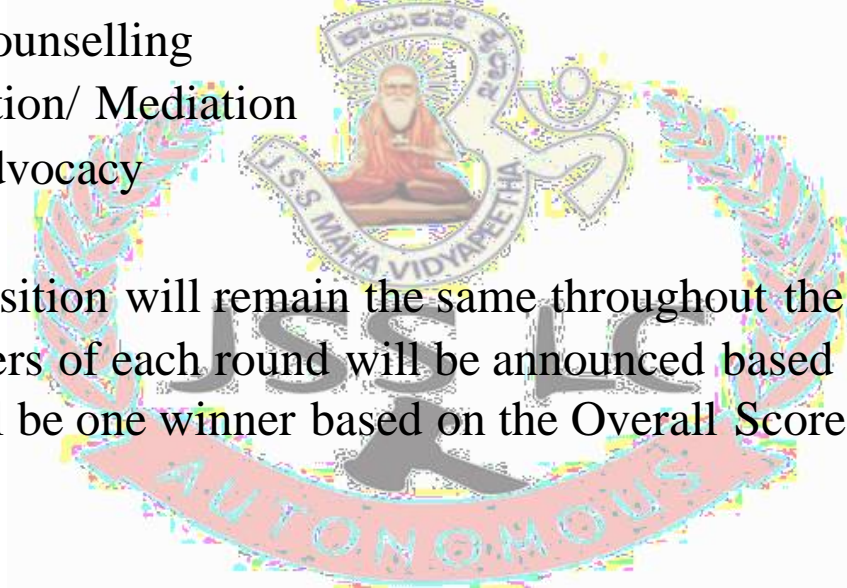
