

**PROCEEDINGS OF THE INTERNAL QUALITY ASSURANCE CELL (IQAC) (Third) MEETING HELD
ON 28th May, 2025**

The IQAC meeting was chaired by the Principal and she welcomed the members. Members were briefed about the agenda and the same was placed before the members.

AGENDA 1 – Reading and Recording of the previous IQAC meeting

The deliberations and resolutions passed during the online/offline meeting which was held on 8th February, 2025 were discussed and approved.

Dr. Vishnuprasad R appreciated that, the quality of IQAC proceedings as good, but insisted that proceedings of IQAC meeting shall be elaborately recorded as it is officially accepted and also to be uploaded on the college website.

DECISION – Proceedings of the previous IQAC meeting was approved

AGENDA 2 – Finalizing the new Vision & Mission of the College

The vision and mission of college was displayed to the members. Dr. K. Vikram suggested reconsidering / changing the jargons and shortening the vision. He suggested that, Vision shall be measurable and Mission shall be achievable. Further, he advised that, no general statements shall be made and to focus on short term goals and include legal research. Smt. Nandini M.S suggested replacing the word 'JSSLC' with 'We'. Dr. Vishnuprasad R suggested adding the word inclusive environment. Academic excellence to be retained as it is the core element of the college. The members were informed that draft will be sent after consultation with experts and peer members.

AGENDA 3 – Activities Report (May 2025 to July 2025)

Detailed half yearly report was placed before the members. Dr. Vishnuprasad R sought clarification about mentor-mentee system. Dr. N. Vani Shree explained the system practiced in the college. Mr. Jiss Anthony, Student of VIII Semester BA LL.B. (Hons.), IQAC student member gave an overview of the existing mentor-mentee system. Dr. Vishnuprasad R informed that emotional problems have to be addressed by teachers by breaking down the

total number of students into smaller groups, and was also suggested to have the facility of a counsellor.

Dr. K. Vikram informed to organize training programmes for faculties by NIMHANS (Centre for Life Skill Training), and also to have collaboration with NIMHANS, Bengaluru. Smt. Sheela Ganesh informed the members that suggestions were made by Dr. Chandrakanth from JSSAHER to appoint a Clinical Psychologist (in the Academic Council meeting). Dr. Vishnuprasad R informed that, a formal (Structured) documentation is a requirement of peer mentorship for NAAC purpose. Prof. B. Niranjanmurthy sought for a standard format to be drafted for mentorship programme to which the Principal explained about the existing structure of mentorship programme and documentation. Dr. K. Vikram informed that 1:24 Mentor-Mentee ratio could be ideally adopted.

Dr. N. Vani Shree informed about the mental health programmes and trainings conducted in the college. Dr. Vishnuprasad R informed that teacher's involvement should be there along with students' participation. The teachers are required to spend more time with academically poor and slow learners and guide them accordingly. Dr. Shwetha P informed to meticulously maintain the records of the Mentorship Programme.
